



## INSURANCE REQUIREMENTS FOR NON-UIIA MEMBERS

Effective October 7, 2019, insurance for TRAC Intermodal customers is handled by the Intermodal Association of North America (IANA). Your company will need to register online and establish an account in IANA's system. <https://www.uiia.org> Once registered, your company will need to have your insurance agent submit a certificate of insurance to IANA that contains the necessary information to meet TRAC's requirements:

- **Commercial Auto Liability** with limits of at least **one million (\$1 million)** combined single limit.
- **Type of Auto** policy shown on the certificate must be marked "**Any Auto**", "**Scheduled and Hired**" or "**All Owned and Hired**". "Scheduled Only" or "All Owned Only" is not acceptable.
- **Commercial General Liability** with limits of **one million (\$1 million)** per occurrence. No portion of the General Liability policy may be self-insured.
- **Trailer Interchange/Physical Damage** policy covering physical damage to the non-owned equipment while in the Motor Carrier's care, custody and/or control with limits of **\$25,000 per trailer and with a zero (\$0) deductible**.
- **Interpool, Inc. d/b/a/ TRAC Intermodal, its subsidiaries, affiliates and Chassis Lessors** are to be listed as additional insured on the Motor Carrier's Auto Liability, General Liability and Trailer Interchange policies. **Please note that the full name company name as shown above must be included as the additional insured on the respective policies in order to meet this requirement.**

## INSURANCE REQUIREMENTS FOR UIIA-MEMBERS

- **Commercial Auto Liability** with limits of at least **one million (\$1 million)** combined single limit.
- **Type of Auto** policy shown on the certificate must be marked **“Any Auto”, “Scheduled and Hired”** or **“All Owned and Hired”**. “Scheduled Only” or “All Owned Only” is not acceptable.
- **Commercial General Liability** with limits of **one million (\$1 million)** per occurrence. No portion of the General Liability policy may be self-insured.
- **Trailer Interchange/Physical Damage** policy covering physical damage to the non-owned equipment while in the Motor Carrier’s care, custody and/or control with limits of **\$25,000 per trailer and with a zero (\$0) deductible**.
- **Interpool, Inc. d/b/a/ TRAC Intermodal, its subsidiaries, affiliates and Chassis Lessors** are to be listed as additional insured on the Motor Carrier’s Auto Liability, General Liability and Trailer Interchange policies. **Please note that the full company name as shown above must be included as the additional insured on the respective policies in order to meet this requirement.**

Effective October 7, 2019, insurance for TRAC Intermodal customers is handled by the Intermodal Association of North America (IANA). If your insurance meets the requirements above, the only information your insurance agent will need to submit to the UIIA is the additional insured information for TRAC. When submitting the additional insured information online at [uiia.org](http://uiia.org), your agent will select from the EP listing, **Interpool, Inc. d/b/a/ TRAC Intermodal, its subsidiaries, affiliates and Chassis Lessors (Non-UIIA EP)** and identify that the additional insured is applicable to auto, general and trailer interchange.
